This invitation for prequalification follows the general procurement notice for this project that appeared in Development Business on-line, on April 15, 2015.

The **Islamic Republic of Pakistan** intends to apply for a **loan** from the **International Development Association (IDA)** toward the cost of the **Sindh Barrages Improvement Project**, and it intends to apply part of the proceeds to payments under the contract for **River Training Works at Guddu Barrage, Kashmore**.

Works include:

- Strengthening, raising and widening of the existing upstream and downstream embankments and river training works on the left and right banks of the River Indus at Guddu Barrage.
- Construction of a single additional spur on the left bank of the River Indus upstream of Guddu Barrage to improve the river approach conditions.

Prequalification will be conducted through prequalification procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, January 2011*, updated July 2014 and is open to all bidders from eligible source countries, as defined in the guidelines. The project has hired Food and Agriculture Organization (FAO) as Project Management Consultants supporting the procurement processes and Transparency International acts as an observer in all bid openings. Interested eligible Applicants may obtain further information from and inspect the prequalification document at the **Irrigation Department, Government of Sindh, Pakistan** (address below) from **office hours from Monday to Friday**.

Hard copies of the prequalification documents may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **PKR 15,000 or US\$ 180**. The document will be sent by registered courier. Payment of the above fee is essential for the pre-qualification application.
